Dear Parishioners,

St Theresa's Parish is so blessed in having you all as our parishioners. Despite the impact of the COVID 19, your continued support to the parish helps us to continue to provide for the needs of our church. My deep appreciation for your contribution to our parish through your time, your talent, and your treasure.

I am writing to update you on how we are doing as a parish faith community and to report to you our Parish Financial Report for 2020.

During our parish closure (mid-March to late June), we reached out to you through our social media channels and via livestream of the Sunday mass. Since our re-opening in June, we are proud to have ensured a safe environment for worship here at St. Theresa's Parish through the hard work of many volunteer cleaners, ushers, the staff, and digital volunteers, in addition to the continued involvement of readers, extraordinary ministers of the Eucharist, and Deacon Peter Lovrick.

Social distancing has impacted attendance at Sunday Masses. We know that this may continue for some time and are happy to be live streaming *Sunday Mass* and *our Tuesday Devotion to St Theresa, Friday devotion to the Most Sacred Heart of Jesus* to the faithful community especially to those who cannot attend in person due to health or other issues at this time.

The pandemic has also had a negative impact on our financial health in 2020. I want to draw your attention to the following items in the Financial Report for 2020:

- Offertory revenue declined by 41.09% as compared to 2019. Similarly, most if not all of our collections have significantly decreased, and understandably because of the difficult times. We thank all those who have continued their contributions to the parish even though many of you cannot attend mass and worship in person.
- We have benefitted from the 75 per cent government wage subsidy (CEWS) for clergy and lay employees. Note that from September to date, the CEWS subsidy has been greatly reduced.
- The Diocesan Assessment indicated in the report covers the period July December of 2019 and January to June 2020.

We have all been negatively affected by the COVID-19 pandemic, whether through isolation, illness or financial challenges. Please do not hesitate to contact the parish if we can assist you during these challenging times. When working remotely, we monitor our messages daily.
